Ms. Hurlbut called the meeting to order at 7:10 P.M.

Members of the Finance Committee continued their review of the budget proposals for FY21.

The budgets of the following departments were reviewed:

• Town Moderator

A motion was made by Mr. Kelliher and seconded by Mr. Gamer to accept the Town Moderator budget in the amount of \$50. **Vote: Unanimous**

• Finance Committee

A motion was made by Mr. Gamer and seconded by Mr. Kelliher to accept the Finance Committee budget in the amount of \$1500. **Vote: Unanimous**

• Fuel/Vehicle Pool

A motion was made by Mr. Gamer and seconded by Mr. Pulver to accept the Fuel/Vehicle Pool budget in the amount of \$151,500. **Vote: Unanimous**

• Emergency Management

A motion was made by Mr. Gamer and seconded by Mr. Stuto to accept the Emergency Management budget in the amount of \$3478. **Vote: Unanimous**

• Code Enforcement

Department requested an increase for a new part-time inspector position. Finance Committee chose to vote the budget less the new position.

A motion was made by Mr. Gamer and seconded by Mr. Stuto to accept the Code Enforcement budget in the amount of \$345,054. **Vote: Unanimous**

• <u>Veterans Services</u>

Overall budget slightly higher than FY20 due to contractual obligations. FY20 new position has been on hold and will remain on hold for the time being.

A motion was made by Mr. Pulver and seconded by Mr. Kelliher to accept the Veterans Services budget in the amount of \$344,630. **Vote: Unanimous**

• Conservation Commission

Budget increase of 6.8% due to contractual obligations. Current agent's contract has expired and is in negotiations.

A motion was made by Mr. Gamer and seconded by Mr. Kelliher to accept the Conservation Commission budget in the amount of \$45,745. **Vote: Unanimous**

• <u>Town Administrator</u> (REVOTE)

A motion was made by Mr. Pulver and seconded by Mr. Gamer to rescind the vote on the Town Administrators budget (from 3/25/20). **Vote: Unanimous**

A motion was made by Mr. Gamer and seconded by Mr. Pulver to accept the Town Administrator's budget (less new position) in the amount of \$294,703. **Vote: Unanimous**

• Finance Department

A motion was made by Mr. Gamer and seconded by Mr. Kelliher to accept the Finance Department budget in the amount of \$216,994. **Vote: Unanimous**

Accounting

A motion was made by Mr. Gamer and seconded by Mr. Pulver to accept the Accounting budget in the amount of \$208,502 which included a reduction to professional services by \$20,000. **Vote: Unanimous**

• Youth Services

A motion was made by Mr. Pulver and seconded by Mr. Kelliher to accept the Finance Committee budget in the amount of \$61,526 reduced by eliminating the part time position in the amount of \$25,000.00 **Vote: Unanimous**
