Mr. O'Leary expressed his opposition to the route Kinder Morgan is taking. He said they are taking the easiest route financially at a big impact on the community. Mrs. Manupelli expressed her concern about environmental and conservation land that may be affected by the route. Chairman Mauceri requested the Board think of questions that could be included in the survey.
