TOWN ADMINISTRATOR'S REPORT

Topics Discussed:

- A mosquito tested positive for West Nile virus near Maple Road;
- Due to the drought, there will be no hydrant flushing this fall. Mr. Mauceri suggested stretching the flushing out through November, because the hydrants are tested at the same

time. Mr. O'Leary inquired why the Town has not gone to a different water stage; he stated that we have imposed greater restrictions in the past. Mr. Gilleberto responded that the system continues to perform. Mr. O'Leary responded that the Town is not helping regionally.

- Application for Mass Works program for \$2.5 Million Dollars to cover the cost of the pump station:
- Gave status of road repair schedule and paving projects;
- Grant for \$50 Thousand Dollars for improvements at Benevento Field in conjunction with Little League.
