UPDATE ON MWRA/READING/ANDOVER WATER DISCUSSIONS

Mr. Mauceri gave an updated power point presentation titled Water – MWRA or Andover. It reviewed the status of discussions with Andover and the status of the MWRA project. Members of Andover Board of Selectmen were present as well as Andover's water consultants. Rob Williamson of Wright Pearce assured the Board that the Merrimack River basin has an infinite supply of water and there will be no long term issues getting water from there. As part of the permitting process, Andover will have to make sure the system is efficient enough to deliver the maximum amount of water to the Town. The Board was informed that a water flow test nearthe Town line with Andover was done within 12 months and it was good. The Town could be in a position to open the valve July 1, 2019. Mr. Prisco thanked the Andover BoS for their vote last week. Mrs. Manupelli expressed her appreciation to the members of the Andover Board for their commitment to North Reading. Mr. Schultz stated it is good to have something tangible to work with and the 5 year out concerned him. Andover and North Reading Town Meetings will have to support this agreement.

George Luongo of 18 Ridgeway Road asked the Board if this agreement could be more permanent than 99 years. Jeff Yull of 27 Park Street thanked all involved in working together to come up with a solution. Mr. O'Leary commented that the MWRA and Reading have been great throughout the entire process. Mr. Schultz thanked Andover, Reading, Mr. Mauceri and Mr. O'Leary for their efforts.
