7.	Two (2) copies of plans	
8.	"PDF plan emailed to <u>planning@northreadingma.gov</u> " at time of filing	
9.	All runoff, drainage calculations and compensating flood storage proposal with a report describing all proposed alterations of floodplains, mitigation measures and	d construction methodology.
10.	Evidence of filing with Town Clerk	
11.	Letter of authorization if applicant is other than owner	
12.	Brief letter of explanation describing the proposal	

NOTE:Other supporting documentation including, but not limited to, drainage calculations, traffic studies, decisions of other Boards, conditions of Covenants already imposed, etc. may be required by the Community Planning Commission prior to final approval.
