Next order of business. Update on Various Town Intersection Projects

Mr. Gilleberto had some prepared remarks:

On March 3rd a North Reading resident lost her life in an automobile accident at the intersection of Park and Central streets. She and her family are in all of our thoughts and prayers and while the circumstances of the accident remain under investigation and it's unclear if anything related to the intersection itself caused or contributed to the accident. I think this accident has increased all of our focus on the issue of intersection safety. Board members have expressed concerns regarding intersections in town in previous meetings and I wanted to take this opportunity to provide the board and the community an update.

For the past few years we have been planning for potential improvements at four intersections. Chestnut streets, Park and Central streets, North and Central streets and Park and Concord streets. The Select Board received a report on the issues with and potential improvements to each of these intersections in late 2021. At the time Haverhill and Chestnut Street was identified as the first priority in part because it was potentially eligible for State funding. These intersections were each submitted to the Capital Improvement Planning Committee for consideration in the fiscal year 2023. As a result of the Capital Improvement Planning Committee's ranking process. Mr. Keller just referenced one intersection, Haverhill and Chestnut Street, was advanced for final design and construction funding and the other three intersections were not advanced for funding. Haverhill and Chestnut streets was approved at June town meeting in 2022 short-term improvements that could be made at the other intersections including cutting brush back adding signage and restriping travel Lanes occurred in 2022 shortly after the June 2022 approval.

A State Transportation Bond bill was approved and included earmarks for three of the intersections everyone Chestnut Park and Central and North and Central this funding is earmarked for North Reading but is not available to the town until such time as it's released by the state. Administration with this process can take years depending upon the earmark. I'm in constant communication with Representative Jones about the release of these funds as well as other funds that might be made available at the state level in place of a bond earmark for the Hillview and Chestnut design will be brought forth for public review sometime in the next few weeks. I expect there will be a public hearing as well as a review before the select board. The DPW resubmitted the other three intersections for consideration for the fiscal year 2025 Capital process. However in consultation with the capital of global planning committee they will be considered during the fiscal year 2024 process for potential funding at the upcoming June annual town meeting. The DPW director is also asking our Engineers to update all cost estimates for consideration by the capital Improvement planning committee for Park and Central streets. We're also working with the engineer and the homeowner to potentially install a guardrail in the short term. I know there's a lot of concern in the community for each of these intersections. I want the community to know that we are working within the resources that we have available but that they have been limited, we're hopeful that town meeting will approve additional funding in June for the remainder of the intersections thank you.

Chair Manupelli asked for an updated estimate on those.

Mr. Kelliher said \$820,000 is in there. We don't know what the cost of the guard rail is. As he understands that would be enough to take us through the construction

Mr. Gilleberto said that was our understanding of the time the projects were submitted but because of the cost issues we've seen with nearly every project we're asking for an update

Chair Manupelli added that they can do some things now and not wait.
