MINUTES OF BOARD OF SELECTMEN MEETING THURSDAY, JUNE 14, 2018

Chairman Prisco called the meeting to order at 8:33 a.m. in Room 14 at the Town Hall in the presence of members Mrs. Manupelli, Mr. Schultz, Mr. Mauceri, Mr. O'Leary, and Town Administrator, Michael Gilleberto.

CALL TO ORDER OPEN SESSION

Chairman Prisco called to order the open session at 8:33 a.m.

INTERMUNICIPAL AGREEMENT FOR POTABLE WATER WITH THE TOWN OF ANDOVER – VOTE TO APPROVE AND SIGN POTABLE WATER AMENDMENT

Mr. Gilleberto informed the Board that minor changes to the language were made to the agreement approved by the Board on Thursday night. The changes were minor and not substantial. Mr. Gilleberto further stated that the Governor signed the home rule petition into law at 2:05 p.m. yesterday (Wednesday). There is a 7 day window from yesterday where both parties need to sign an amendment to the 99 year agreement. Mr. Gilleberto wanted it noted that there was a very aggressive timeline against dozens of other home rule petitions, and that Senator Tarr and Representative Jones made the bill move quickly through the House and Senate.

Mr. Mauceri suggested inviting Representative Jones, Senator Tarr and the Governor when the ceremonial signing takes place. Mr. Gilleberto agreed that a ceremonial signing is in order. Mr. Mauceri stated it would be more appropriate to sign the Agreement in Andover.

Mr. Gilleberto stated that the final acts to make the agreement effective are permitting and obtaining appropriations for any improvements Andover may need to make.
