Francis DeCoste of TRA gave a power point presentation to the audience showing the results of the Market Analysis and appraisal of the JT Berry Property. Paul O'Leary addressed the Board regarding other potential uses for the property and possibly changing the current zoning restrictions. Mr. Prisco informed the audience that the Economic Development Committee is in favor of an open RFP. Mr. DeCoste stated that he hopes to get the RFP out by Labor Day and have a P&S by October 17<sup>th</sup>. He also stated Fore Kicks is interested in developing the property. Mrs. Manupelli appreciated the presentation but would like to see other potential developers. Chairman Mauceri would like the development to go forward with the minimum amount of restrictions "to get the biggest bang for our buck."

#### TOWN ADMINISTRATOR'S REPORT

No Report.

### **OLD AND NEW BUSINESS**

Mr. Prisco – Informed the audience that the Commercial tax rate is the same as Residential tax rate. We are at the top for residential tax rate and commercial tax rate is favorable for businesses. He stated that the Governor's budget team is working with Representative Jones and North Reading Little League to secure a Fifty Thousand Dollar Grant because the Little League World Series will be held in North Reading. He thanked Representative Jones and Senator Tarr for the 25 Thousand Dollars for CIT in the budget. He asked Mr. O'Leary about the fields at the High School and raising money to finish the project. He inquired about any free cash in the Town's budget to finish the project as he feels it has become a public health issue with no grass there. There is too much dust. He stated the residents have put up with too much already.

**Mrs. Manupelli** – Congratulated the U12 Boys Soccer team for winning the league championship. Her son Matt is on the Team. She Informed the audience about Youth Services National Night Out on August 2<sup>nd</sup> at IRP. Mrs. Manupelli will plan on attending. Chairman Mauceri responded that he needs volunteers from the Board for National Night Out. Mr. Prisco and Mr. O'Leary responded they plan on attending.

**Mr. Yull** –Is concerned about what is going on in the Country right now. He said it is like the 1960's all over again.

**Mr. O'Leary** – Informed the audience that the Chamber of Commerce is looking for help from the DPW for holiday lights on the Common. Mr. Gilleberto responded that he is aware and will bring a proposal to the Board at the August 22<sup>nd</sup> BoS meeting. Mr. O'Leary would like the Board to consider a by-law change to allow for alcoholic beverages on Town property, especially for the Farmers Market. Mr. Gilleberto will consult with Town Counsel about this but believes there may be an avenue for this in the current bylaw. He acknowledged the passing of former Town Administrator Chet Spinney. He thanked the Board for the courtesy they extended to him at the passing of his Mom.

**Mr. Mauceri** – Thanked the employees of the DPW who have stepped up, he stated, "things are getting done." He also thanked Chief Murphy who stepped up as Town Administrator while Mr. Gilleberto was on vacation. He stated that is it important to maintain a well-trained police force with what is going on in the world today.
