## PUBLIC HEARING: 202 NORTH STREET, INC., D/B/A 28 BEER AND WINE TRANSFER OF PACKAGE STORE/WINE AND MALT BEVERAGE LICENSE

7:43 – Chairman Mauceri reads the Public Hearing Notice.

This is a continuation of the Public Hearing from August 1, 2016. The Board requested clarification on the business. Attorney Joseph Devlin and Vivek Patel were in attendance to represent 28 Beer and Wine and to answer questions from the Board. Mrs. Manupelli appreciated the clarification they provided however she does not see a public need for another beer and wine store, especially with so many others in such close proximity. Chris Pendleton, former owner of Tedeschi's addressed the Board informing them that 1.5 Million Dollars was given to the Town in 2015 from Lottery sales, his store was in the top ten of the state for sales. Mr. Prisco stated a liquor license is not an entitlement, it is a privilege and should not be used for selling tobacco and lottery tickets. He further stated that it does not fit into the Strategic Plan and this type of store does not provide a service that fits in the community. He is not in favor of transferring the license.

Mr. Yull stated that he likes the revenue that the lottery sales produce for the Town. He further stated that Vivek should be given the opportunity to operate a business in Town. Mr. Yull will support this transfer for the purpose of continuing to generate revenue for the Town. Mrs. Manupelli stated that he can still sell lottery and tobacco without selling alcohol. Mr. Prisco stated there are 15 locations to purchase lottery tickets and 11 locations to purchase beer and wine therefore there is no need to assign a liquor license at this location. Chairman Mauceri stated he is pro-business but is not in favor of this business, there are too many restrictions on the lease.

Mr. Pendleton inquired about using his license elsewhere if it cannot be transferred. The Town Administrator suggested, and the Board agreed, to give Mr. Pendleton 60 days to see where things stand for him. The Board could at that point schedule a Show Cause Hearing to potentially cancel the license. Chairman Mauceri suggested scheduling a hearing for a date after Town Meeting on October 17<sup>th</sup>.
