Building permits for new homes and additions will only be issued after foundation as-built is received and approved. Submittal of application is not approval for construction to commence. Be advised Permit is required on site as per Massachusetts State Building Code R109.4. Any work commencing without obtaining a Building permit shall be subjected to a FINE of \$100.00 and a DOUBLE PERMIT FEE.
