In order for an application to be considered "COMPLETE" all of the following items must be submitted:

1.	One (1) copy of an application form (application fee \$100.00)	
2.	Vicinity ownership map	-
3.	Two (2) copies of the site plans	
4.	"PDF plan emailed to <u>planning@northreadingma.gov</u> " at time of filing	
5.	A letter from owner authorizing the applicant to file on owner's behalf	
6.	Evidence of filing with Town Clerk (To be provided by the CPC office at the time of submittal.)	
7.	Evidence that taxes are paid up to date	
8.	A brief letter of explanation	
9.	Compete certified list of abutters (Obtainable from North Reading Assessing Office)	
10.	Proof of certified mailing of legal notice of public hearing sent to all abutters on certified abutters list with the certification sent back to the Planning Dept.	
11.	One set of envelopes addressed to all abutters on certified abutters list with postage paid for mailing Notice of Decision	

<u>NOTE:</u> Other supporting documents including, but not limited to drainage calculations, traffic studies, the decisions of other boards, conditions, covenants or permits already in effect, etc. may be required by the Community Planning Commission prior to a final decision. All costs incurred from legal advertisements and abutters notices will be borne by the applicant.
