AMENDMENT TO CONTRACT FOR THE COLLECTION AND REMOVAL OF SOLID WASTE AND RECYCLABLES FOR THE TOWN OF NORTH READING

This Contract Amendment is entered into this ____ day of June, 2019 by and between the Town of North Reading, a municipal corporation in the Commonwealth of Massachusetts, with offices at North Reading Town Hall, 235 North Street, North Reading, Massachusetts 01864, acting through its Town Administrator (hereinafter the "Town") and JRM Hauling and Recycling Services, Inc., a Massachusetts corporation with offices located at 265 Newbury Street, Peabody, Massachusetts 01960-1315 (hereinafter the "Contractor")

RECITALS

WHEREAS, The Town desires to supply its residents and municipal facilities with curb-side solid waste and recyclable disposal services, and;

WHEREAS, The Town hereby designates the Director of the North Reading Public Works Department (hereinafter the "Director") as its agent for all matters relating to the day to day performance of this contract; and;

WHEREAS, The Contractor is in the business of collecting, transporting and disposing of such municipal solid waste and recyclables; and;

WHEREAS, The Town and the Contractor entered into a contract for a three (3) year term commencing on July 1, 2006 and ending on June 30, 2009; and;

WHEREAS, The Town and the Contractor extended said contract for an additional three (3) year term, commencing on July 1, 2009 and ending on June 30, 2012; and;

WHEREAS, The Town and the Contractor extended said contract for an additional one (1) year term, commencing on July 1, 2012 and ending on June 30, 2012; and;

WHEREAS, The Town and the Contractor extended said contract for an additional five (5) year term, commencing on July 1, 2013 and ending on June 30, 2018; and;

WHEREAS, The Town and the Contractor extended said contract for a one (1) year term, commencing on July 1, 2018 and ending on June 30, 2019; and;

WHEREAS, The Town and the Contractor want to extend said contract for an additional two (2) year term,

NOW THEREFORE, in consideration of the foregoing, and mutual conditions and covenant contained herein, the parties hereto, intending to be legally bound, do hereby agree as follows:

All terms and conditions of the Contract for the Collections and Removal of Solid Waste and Recyclables
for the Town of North Reading by and between the Town and the Contractor for the tem commencing
July 1, 2006 and ending June 30, 2009, as amended by the amendments provided in the Recitals above,
not expressly amended or modified herein remain in full force and effect.

AMENDMENT TO THE CONTRACT FOR THE COLLECTION AND REMOVAL OF SOLID WASTE AND RECYCLABLES FOR THE TOWN OF NORTH READING

- 2. Article II, Term of Contract, is amended by deleting the words "July 1, 2013" and "June 30, 2018" where they appear in said Article and replacing them with 'July 1, 2019" and "June 30, 2021", respectively.
- 3. Article III, Compensation, is amended by deleting the contract price table and replacing it with the following:
 - a. New rate for weekly solid waste and recycling collection is as follows:

July 1, 2019 to June 30, 2021: \$835,000.00 Annually*

*If the Town directs Contractor to perform more than four (4) yard waste collection events, as set forth in Article I, Scope of Services, Contractor shall charge the Town \$6,000.00 for each event; and if Town directs Contractor to perform less than four (4) events, Contractor shall credit the Town \$6,000.00 from the Annual rate for each event below four (4).
