Acceptance of Minutes:

RM made a motion to rescind prior motion of March 4, 2019 meeting on dugouts and accept the following:

"Motion to accept donations for the dugouts by the North Reading Youth Girls Softball League. NR Schools have final decision on plaque on said dugouts to be consistent with school committee signage."

NEW Business:

Discussion was had on whether we should or should not charge "special hardship permit requests". P&R was approached by an individual looking to run a fundraiser for a local family, but asked for no charge for the permit. After discussion it was determined that the Town puts P&R in a position where we are in charge of upkeep, maintenance and improvements to the park. We are limited with permitting and raising funds if we do not charge fundraisers and non-profits, which are a great deal of our permits.

It was agreed by all to charge all permit requests a fee.

OLD BUSINESS:

Walkways at IRP: EJ Paving will be paving around Recreation Center in April. Half mile loop to be completed in June and walkways around IRP in July.

Parks Director: (MT):

• Trailer/Shed purchase: RM — sub-committee met today to discuss and vote on which shed to purchase. 3 to 1 voted for the Victorian Cottage. RM was interested in meeting to possibly discuss further the two final choices (Victorian Cottage and Gambrel). It was determined that a Special Meeting to present and Vote on the two final choices and finalize color (green/gray).

Budget: \$25,000, price of shed \$14,300. Our plan is to also add electric so we can put freezer and refrigerator in shed.

Recreation Director (LC): Not present.

- MS Spring/Summer Brochure is out. We are taking registrations.
- Interviewing to hire summer staff.

Operations Director (MS):

- Budget Presentation went well, BOS praised Parks & Recreation.
- Need to sit with BOH for concession and BBQ. Would like to open concession for this coming weekend.

LUC (RM):

RM – LUC voted to spend \$2,500 for picnic tables. MT/MS finalizing final cost per table

CIT (RM):

- Unfortunately Parent University was not well attended. Feedback from a few parents was that the sessions they attended were eye openers (CIT - drug bedroom/social media presentation by HS student).

FONRPRC (MS):

- W&F sold 250 tickets. 2019 auction overall total \$15,807, 2018 was \$12,300. MS also mentioned that we would like to change the etching on the wine glasses to "01864". Office staff will discuss final look.
- BBQ all dates booked and sponsored. MS needs to discuss with BOH and PF on compliance.


