Our spring/summer registration is in full swing. Registrations coming in strong.

Special Municipal Employees – discussion with HR.

We will be offering SummerScape. We will not offer Kid Connection this year. Preschool age is tough with Covid-19 guidelines and spacing needed. Would not be profitable. We will have a maximum of 80 in SummerScape. We will be able to offer 8 weeks. They will have to register for a full week at a time. Not offering field trips, but entertainers weekly. Our numbers will be limited for BC/AC. Working on hiring staff. Scheduling a meeting with Directors we were going to hire last year.
