Mrs. Manupelli reads the Public Hearing Notice. Applicant Nick Yebba and Nick Yebba, Jr. were in attendance. Mr. Gilleberto confirms that Mr. Yebba provided proof of certified and first class mailing of the hearing notification to abutters. He informed the audience that some residents did not receive notification because they are not direct abutters. The following residents expressed their opposition to the pool table license:

Tom Woo, 40 Riverside Drive – Stated neighbors on the even side of his road did not receive notification. He further stated there has been noise complaints against Teresa's made to the NRPD.

Jeff Stolz, 2 Gillis Drive – Stated Mr. Yebba's business model has changed dramatically since he first opened, he did not fulfil his responsibility with notification for the first hearing, and he is continuing to advertise the pool tables are open.

Sandy Woodmansee, 34 Elm Street – Stated he is no longer in favor of the pool table license, business model in 2012 did not include pool tables, did not get notified of the first hearing, is not what a residential neighborhood deserves, and has an issue with 3 pool tables.

Susan Holsing, 36 Niblick Way – Stated ignorance of the law is not a reason for not applying for a license.

Allen Helferich, 8 Lynn Street – Stated he saw an advertisement indicating the game room was open with automatic amusement devices and pool tables. Mr. Gilleberto responded a license was granted for the automatic amusement devices, but the pool tables should be covered.

Nicholas Holsing, 36 Niblick Way – Stated the advertisement included "#pool tables".

Wendy Emerson, 100 Lowell Road – Stated North Reading needs more things to do; it would be good to have more entertainment in North Reading.

Michael Myette, 3 Childs Road – Stated he is against the pool table license because of the way Mr. Yebba went about it.

Allen Helferich, 8 Lynn Street – Inquired if electrical and building permits had been pulled for the game room. Mr. Gilleberto responded that the Building Department did not comment that there were any issues however he will look further into it.

### 8:30 – Public Hearing closes.

### Mr. Yebba responds:

- Licensed until 1:00 am, usually close between 10:00-10:30;
- Game room is soundproofed;
- Assistant General Manager will be watching game room which will be restricted to over 21 years of age;
- Filed for an entertainment license when he first opened, but did not realize it did not cover games and pool tables;
- Grille 19 has never had a police complaint, but the pool (Resorts North) has;
- Coin slots on Pool tables will be taped on Sundays.

### Select Board responds:

- Mr. Gilleberto states the TA's office did not receive proof of the first notification mailing;
- Mr. Wallner states false advertising misleads people;
- Mr. Schultz states Mr. Yebba has made many missteps and wants to make sure the rules are being followed. He used T's Tavern as an example.
- Mrs. Manupelli states only the license application should be discussed;
- Mr. O'Leary states this application process is different because of the other issues associated with Mr. Yebba. He further stated he will support the license application and if it doesn't work out, the Board can pull it.
- Mrs. Manupelli states Mr. Yebba's business model is shifting, the Board told him he had to cover the pool tables until he got a license, and he advertised the game room was open with pool tables, the Board can have a Show Cause hearing to revoke a license if there are too many public disturbances.
- Mrs. Gonzalez expressed her concern about pool tables being in a residential neighborhood.
- Mr. Gilleberto clarifies who was included on the abutters list and the number of units at the Greens. He further stated there are outstanding issues with the Fire Department and Health Department that would need to be complied with before the license is issued.
- Mr. O'Leary suggests since Mr. Yebba advertised the pool tables were open one month prior to obtaining a license, the license should be effective one month after the license is issued.
- Mr. Wallner suggests waiting to issue the license when they see there has been no advertising.
