COVID 19 UPDATE

Mr. Gilleberto states:

- With the extension of the Governor's stay at home advisory, the Town Hall, Library and Senior Center is closed to the public and more information is posted on the Town website.
- The nursing home continues to be monitored and the Town is working with DPH in this situation.
- Effective Wednesday, face coverings must be worn in public.
- Looking to potentially see loosened restrictions after May 18th and working on getting the workforce back.
- Spoke with Veteran's Agent and Rich Stratton about a Memorial Day Celebration. More information regarding how to recognize Memorial Day will be provided in the next few days.
- Mrs. Manupelli inquired if there is an update on the issue of families not being able to speak with family members in the nursing home. Mr. Gilleberto responded there was a swift response to provide updates to the families and opportunities for families to communicate with their family members.
- Mr. O'Leary inquires if there is enough personal protection equipment for public safety employees. Mr. Gilleberto responded that there is enough equipment for the foreseeable future, that a delivery was received from FEMA and have also received donations.

REVIEW UPDATED FY2021 REVENUE/EXPENSE PLAN

Mr. Gilleberto states Finance Director Liz Rourke is in attendance and the Revenue/Expense Plan is in tonight's meeting packet. Ms. Rourke states:

- Chapter 70 funds were reduced to FY20 amounts. Unrestricted general government assistance was reduced 5%.
- Local receipts have been reduced by Seventy-Five Thousand Dollars, which is based on research from 2008-2010 to be more conservative.
- Excise tax receipts will be impacted in FY2021.
- Meal tax revenue has been reduced.
- Changes on the expense page pertain to School and Municipal Health insurance.
- Discusses municipal and school budget distribution, allocation, and deficits.
- The Fifty Thousand Dollar shortfall in the municipal budget is due to storm water compliance.

Board Members commented:

- Mr. O'Leary appreciates taking a fiscally conservative approach and further stated the Federal government will need to reimburse State and Local governments. Due to the uncertainty of the revenue stream it is difficult to forecast reliability.
- Mr. Wallner is concerned about the big gaps.
- Mr. Schultz thanks Ms. Rourke and states how difficult it is to project revenue streams at this time.

- Mr. Gonzalez states things will get harder and she has great confidence in the financial team.
- Mrs. Hurlbut stated the idea of the stabilization fund is for a major emergency, not to spend on recurring expenses. She further stated the Finance Committee would like to increase the contribution to the stabilization fund.

APPROVE FY 2021 EMPLOYEE HEALTH INSURANCE

Mr. Gilleberto states there is a 7 percent premium renewal increase that includes the plan and the PFA combined which will allow to accrue a balance of between Three and Four Hundred Thousand Dollars. Mr. Gilleberto further stated reducing this amount to cover shortfalls in the budget would not be acceptable to the Financial Planning Team. Mr. Gilleberto stated the budget increase remains at 7 ½ %.

Mr. Gilleberto informs the audience that 2 Articles relative to the Turkey Farm property have been added. Mr. O'Leary suggested having a separate warrant article within the Town Counsel budget for the 40B Project rather than carry the money forward from Fiscal Year to Fiscal Year; Mr. Gilleberto agreed saying it would be more preferable rather than have it in the annual operating budget.
