Any new construction, alterations	FEES
Minimum Residential Permitting Fee	\$50.00
Foundations for new homes and additions, fee shall not be subtracted from building permit.	\$200.00 Street bond per Town Engineer \$1500.00
New construction including, new structures, additions, remodeling, alterations, windows, siding, etc.	\$12 per thousand construction cost. The construction cost shall parallel with ICC Building Valuation Data.
Demolition Permit	\$100.00, plus street bond per Town Engineer \$1500.00
Chimneys	\$12.00 per thousand
SHEET METAL	FEES
New construction, additions HVAC/Sheet metal	\$12.00 per thousand
Replacement HVAC system no sheet metal	\$50.00
Sheet Metal Only	\$12.00 per thousand of cost of work
SWIMMING POOLS	FEES
In ground pool, requires fence design at same time	\$12.00 per thousand Plus Street Bond Per Town Engineer \$1500.00
Above ground pools, may require fence design	\$100.00

5% of cost of sign and labor	\$50.00 Minimum

ROOFING PERMITS RESIDENTIAL	FEES
Minimum Commercial Permit Fee, Including Occupancy	\$100.00
New construction including interior alterations	\$13.00 per thousand

Payment is due at time of application. Please be advised permit fees are non-refundable.

Building permits for new homes and additions will only be issued after foundation as-built is received and approved.

Submittal of application is not approval for construction to commence. Be advised Permit is required on site as per Massachusetts State Building Code R109.4. Any work commencing without obtaining a Building permit shall be subjected to a FINE of \$100.00 and a DOUBLE PERMIT FEE.

Revised 1/11/2019 – Unlisted fees shall be determined by the Building Official.

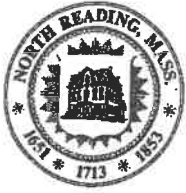

<b>Outlets, Switches, Luminaires, etc. 1-10</b>	<b>\$65.00</b>
<b>11-20</b>	<b>\$85.00</b>
<b>Anything over shall be determined by Building Official or Electrical Inspector.</b>
