Acting Chair, Jim Demetri opened the meeting at 7:30 PM

## 8 Hancock St. - Variance for an inground pool

Mr. Demetri opened the Public Hearing and read the notice. Mr. and Mrs. Pellegrino were present. The Pellegrinos have an above ground pool now and are proposing to install a 12' x 24' inground pool. Because of the size of their lot, they would not be able to meet the 10' setback. Their septic system is located in the front yard. The Planning Committee submitted a memo, that was read outloud. Mr. Amara at 11 Bliss Rd was present and stated that he was in favor.

Mr. D'Angelo moved to grant a 5 foot variance to the northerly side yard setback and a 5 foot variance from the rear yard setback. Mr. Bellavance seconded the motion; and it was voted 3-0.

### 435 Park St. - Special Permit for chickens

Mr. Bellavance moved to continue the Public Hearing to November 7, 2019; it was seconded by Mr. Demetri; and voted 3-0. No abutters were present.

#### Minutes

Mr. Demetri moved to approve the minutes of August 8, 2019, August 22, 2019, and October 18, 2019. Mr. D'Angelo seconded the motion; and it was voted 3-0.
